**Meeting Summary for June 12, 2014**  
**CAG Formation for the Colorado Smelter**

The following document is a summary of the discussions that occurred during the June 12, 2014 meeting of the Steering Committee of the Colorado Smelter Community Advisory Group (CAG). **Steering Committee Requests**

Although the CAG is not formally established yet, individual community members made some specific requests of the Environmental Protection Agency (EPA) and others during this meeting and prior meetings. A running list of these recommendations and responses to date can be found in Attachment A at the back of this summary. The CAG will use this list as a way to hold itself and the agencies accountable to their work.

**Next Steps for CAG**

The next meeting date for the CAG Formation Group is July 24, 2014. The group had talked about meeting at additional times in June and July, but agreed that one meeting a month is sufficient. Please remove June 27, July 17, and July 31 from your calendars.

Even though the CAG Formation Group is not meeting on June 26, all are invite to attend the premiere of the movie: Potica, Pints, and Prayers of Old Bojon Town starting at 6:00 p.m. at the library on this day.

**Key Topics Discussed at the May 29 Meeting**

- EPA schedule and updates (slides from presentation in Attachment B);
- Brief update regarding plans for public health education regarding the site (slides from presentation in Attachment C);
- CAG mission statement (draft from discussion in Attachment D);
- CAG membership (slides and list from discussion in Attachments E and F); and
- Next steps and topics for future meetings.

The remainder of this summary provides an overview of each of the above topics.

## EPA Schedule and Updates

Chris Wardell of EPA briefed the slides included here as Attachment B. Other topics discussed include:

- Sampling. EPA is in the process of hiring Pacific Western Technologies as a contractor to conduct sampling in the area. This sampling will be used to help establish the perimeter of the Superfund site and determine appropriate cleanup approaches. EPA will seek landowners' permission to sample on their property by requesting they sign an access agreement. The Agency welcomes community input on determining the best way to seek this permission. Meeting participants asked if they could view and comment on the sampling plan prior to its finalization. Chris responded that there are a wide variety of laws and rules that dictate how EPA must sample, but that EPA would welcome input to correct any major errors or problems. A meeting participant encouraged EPA to take a local community member with them to ask permission to sample and to coordinate outreach to the public. Chris also stressed that sometimes scams develop around EPA Superfund sites and people will pretend to be EPA contractors requesting money to sample property. **EPA does not charge to do sampling. Any requests to pay are scams.**
- EPA Schedule. Chris noted that EPA is clear that an expedient cleanup is very important to the community. EPA is already six to eight months ahead of where the Agency would be on most sites and that he and the EPA Team plan to continue to move things forward quickly.
- CAG input. Some expressed concern that the EPA appears to have so many rules that they are unclear if the CAG can have any influence. The group discussed how their greatest influence is as an organized, cohesive group that can speak with one voice and apply pressure to the agency and other leaders as needed.

## Public Health Education

Chad Wolgram of the Pueblo City-County Health Department provided a short briefing on the planned education actions of the Health Department. His briefing can be found in Attachment C. Topics of interest following his presentation included:

Resources. Chad explained that these resources will be available to anyone who is concerned, even if they are on the border of the site.

Lead Paint/pipes. In response to a question, Chad noted that they will not be condemning houses that are found to have lead paint. They will work with the homeowner to remediate the situation. Chris Nevin-Woods further clarified that houses that do have lead pipes usually only have them for carrying water **out** of the house.

### **CAG Mission Statement**

The facilitator revised the draft mission statement for the CAG based on comments from the last meeting. The new draft can be found in Attachment D. There was one suggested change at this meeting: to add small business owners. The group will use this document to talk to people about the potential role of the CAG. The CAG mission statement will be finalized by the eventual CAG.

### **CAG Membership**

James Williamson briefed the group on the efforts of the working committee, which consisted of Bob Blazich, Julianna Williamson, Kiera Hatton, and Nadine Triste. EPA staff, Chris Wardell and Michael Wenstrom, provided support to the group. The working group reviewed the possible participants list created at the last meeting and identified holes and possible additions. They further identified who might reach out to these additions. A copy of this list can be found in Attachment E. The working group also instructed the facilitator to draft a form for interested community members to fill out if they would like to serve on the CAG. This application of interest (and the suggest revisions) can be found in Attachment F. The thought is that the facilitator will send this application of interest, the mission statement and an EPA fact sheet to the full group and interested parties to seek formal interest in serving on the CAG. EPA will work with the facilitator to send out this package of information to others in the community who might be interested. To the extent that fewer than 30 people apply to serve on the CAG, the group will move forward with those members. If more than 30 are interested, the facilitator will work with the working group to make a recommendation to the current Steering Committee.

The group provided the following recommendations:

- Translate the information into Spanish.
- Kiera Hatton, Terry Hart, and Chad Wolgram will work to determine the potential for getting the application package out to those families who had children who tested high in lead. The group recognized that they are privacy issues that need to be protected, but thought that this could be done in an appropriate way.

- Share this information more broadly through the media and community groups.
- Change the name of the group to the Community Advisory Group—since there are lots of other groups named the Citizens' Advisory Group in the area.
- Terry Hart will contact the School Board to see if they are interested in serving on the CAG
- Pam Kocman will contact Joe DeHeart of the Colorado Department of Transportation (CDOT) to determine CDOT's interest.

### **Next Steps**

The group agreed that they would NOT meet on June 26, but instead go to a monthly meeting schedule. The next meeting is scheduled for July 24 at the Rawls library. Topics for the next meeting will include:

- CAG membership
- Sampling plan
- Plans for the fence
- Access agreements
- Can CAG be formally established before the site is listed?

There was a discussion about whether the CAG can be formally established prior to the site being listed formally on the Superfund site. Kristi, the facilitator agreed to look into this and get back to the group.

There was a discussion about some individuals' perceptions that EPA is inflexible given all of their rules and regulations and that information is not readily accessible—particularly in regard to the health information. Most agreed that the best way to address this would be for the CAG to form a united community on many topics and to try to push forward in a way that makes the most sense for the neighborhood.

    - Will CDOT appraisals be based on current house values?



**POSSIBLE MISSION STATEMENT**

The Colorado Smelter Community Advisory Group (CAG) is an independent, non-partisan group consisting of a balance of diverse interests affected by and concerned about the Colorado Smelter and its cleanup process. Participants include:

- **A diversity of the community**, including representatives from the Eilers and Bessemer neighborhoods and their associations, parents of small children, homeowners, renters, ~~and~~ rental owners and business owners;
- **Local government**, including City Council and County Commissioners, Health Department, and local police; and others as needed;
- **Other interested community members from various organizations** such as the from the Saint Mary's and Saint Joseph's parishes, Better Pueblo, and the Sierra Club; and
- **Other interested community members with important expertise and knowledge** such as backgrounds in real estate, environmental cleanup, environmental law, environmental health, community organizing, community integration and many others.

The overarching goal of the CAG is to have an effective cleanup completed by 2019. The CAG defines an effective cleanup as:

- Not causing health damage to residents or animals, regardless of their age or desire to play in the parks, garden in their yards, or dig for pirate treasure in the neighborhood.
- Restoring the environment to its natural state;
- Promoting the economic vitality of the neighborhood; and
- Revitalizing and preserving the historical assets of the neighborhood.

The CAG intends to assist in achieving this goal of an effective cleanup by 2019 by:

- Providing input advice to the EPA and the other government entities that play a role in the cleanup to improve decision-making for all;
- Sharing information, ideas, and concerns; and
- Serving as a conduit to the larger community.
